A resolution by the Florida Constitution Revision Commission recognizing Jo Dowling for her exemplary services and dedication to the people of the State of Florida.

WHEREAS, the Florida Constitution Revision Commission recognizes the dedicated and extraordinary services of Jo Dowling, in creating a permanent record for the State of Florida, of each of the state constitutions, all amendments adopted or proposed to the constitutions, including each citizen initiative adopted or proposed, and

WHEREAS, this project consumed approximately three years of Ms. Dowling's time, to research, compile and record; this project being in addition to the regular duties of Ms. Dowling's employment as Assistant Librarian for the Florida Supreme Court, and

WHEREAS, this permanent record of the Constitution of Florida is housed at the Florida Supreme Court and accessible through the Internet, and

WHEREAS, this permanent constitutional record is of great importance to the Constitution Revision Commission and to the citizens of Florida participating in this unique process, as well as to generations of Floridians to come, NOW, THEREFORE,

BE IT RESOLVED by the Florida Constitution Revision Commission of 1997-98 that Jo Dowling is commended for her exemplary services and dedication to the people of the State of Florida.

Proposal 69—A proposal to revise ARTICLE IV, ss. 4, 5, Fla. Const.; providing for the appointment of the Commissioner of Education.

Proposal 70—A proposal to revise ARTICLE X, s. 4, Fla. Const.; providing an equity value limitation on the homestead exemption; authorizing the legislature to change the amount of the equity value limitation; providing that the homestead exemption does not apply to property acquired, improved, or the equity value increased with the intent to delay, hinder, or defraud creditors.

-was referred to the General Provisions Committee.

By Commissioner Mills-

Proposal 71—A proposal to revise ARTICLE VI, s. 5, Fla. Const.; providing for open primary elections.

-was referred to the Ethics and Elections Committee.

By Commissioner Mills-

Proposal 72—A proposal to create ARTICLE III, s. 26, Fla. Const.; providing for the revision or amendment of statutory law through the initiative process.

-was referred to the General Provisions Committee.

By Commissioner Sundberg-

Proposal 73—A proposal to revise ARTICLE XI, s. 3, Fla. Const.; providing signature requirements for initiative petitions for constitutional amendments.

-was referred to the General Provisions Committee.

By Commissioner Langley-

Proposal 74—A proposal to revise ARTICLE V, s. 10, Fla. Const.; providing for the election of justices of the supreme court and judges of a district court of appeal; providing for public financing for judicial elections.

-was referred to the Judicial Committee.

By Commissioner Douglass-

Proposal 75—A proposal to revise ARTICLE IV, Fla. Const.; adding s. 14 to that article; providing for a public service commission to be appointed by the governor, subject to confirmation by the Senate; providing terms of office; providing for the enactment of laws not inconsistent with this section; providing for the subject matter of such laws.

-was referred to the Executive Committee.

By Commissioner Sundberg-

Proposal 76—A proposal to create ARTICLE VI, s. 7, Fla. Const.; prohibiting a business entity or labor organization from making any contribution for the purpose of influencing an election held to fill a public office in the state; prohibiting a candidate or other person from knowingly accepting any such unlawful contribution; prohibiting an officer or director of a business entity or labor organization from consenting to any such unlawful contribution the establishment of an independent committee does not constitute an unlawful activity; specify-

ing that the provision of certain indirect support services does not constitute an unlawful activity.

-was referred to the Ethics and Elections Committee.

Proposal 77—A proposal to revise ARTICLE X, s. 13, Fla. Const.; providing that the state and its agencies and subdivisions are liable for damages as a result of their actions to the same extent as private parties.

-was referred to the Declaration of Rights Committee.

Proposal 78—A proposal to revise ARTICLE VI, s. 4, Fla. Const.; deleting provisions that establish term limits for Florida delegates to Congress.

-was referred to the Ethics and Elections Committee.

Proposal 79—A proposal to revise ARTICLE VI, s. 1, Fla. Const.; providing that requirements for placing the name of an independent or minor party candidate on an election ballot must not be greater than the requirements for major party candidates.

-was referred to the Ethics and Elections Committee.

By Commissioner Freidin-

Proposal 80—A proposal to revise ARTICLE III, s. 18, Fla. Const.; requiring that a code of ethics for persons or entities in the exercise of governmental duties which prohibits conflict between public duty and private interests be prescribed by law.

-was referred to the Ethics and Elections Committee.

By Commissioner Rundle-

Proposal 81—A proposal to revise ARTICLE XI, s. 3, Fla. Const.; authorizing supervisors of elections to conduct random signature checks on initiative petitions; specifying time for submitting initiative petitions to supervisors of elections for verification of signatures.

-was referred to the Ethics and Elections Committee.

Proposal 82—A proposal to create ARTICLE VI, s. 5, Fla. Const.; providing that all candidates for election be listed on election ballots.

-was referred to the Ethics and Elections Committee.

Proposal 83—A proposal to revise ARTICLE X, s. 6, Fla. Const.; providing conditions under which private property is assumed to be taken for a public purpose.

-was referred to the General Provisions Committee.

By Commissioner Corr-

Proposal 84—A proposal to create ARTICLE VI, s. 5, Fla. Const.; providing that campaign contributions may be made only by persons who are eligible to vote for the candidate to whom they are making the contribution.

-was referred to the Ethics and Elections Committee.

By Commissioner Sundberg-

Proposal 85—A proposal to revise ARTICLE I, s. 24; ARTICLE III, ss. 1, 2, 3, 4, 5, 7, 8, 9, 11, 15, 16, 17, 19; ARTICLE IV, ss. 6, 7, 9, 13; ARTICLE V, ss. 2, 9, 11, 12, 20; ARTICLE VII, ss. 1, 5, 18; ARTICLE VIII, s. 6; ARTICLE X, ss. 2, 12; ARTICLE XI, ss. 1, 2, 5, 6; ARTICLE XI, ss. 11, 12, 14, Fla. Const., and to create ARTICLE III, ss. 20, 21, ARTICLE XII, s. 22, Fla. Const.; providing for a unicameral Legislature.

Proposal 88—A proposal to revise ARTICLE III, s. 3, Fla. Const.; increasing the length of the regular legislative session and including a mandatory recess; deleting authorization for extending a regular session; deleting limits on business that may be taken up during an extended special session.

Proposal 89—A proposal to revise ARTICLE X, s. 15, Fla. Const.; providing for the use of lottery moneys allocated to education.
