# INTRODUCTION OF PROPOSALS

By Commissioner Hawkes-

**Proposal 90**—A proposal to revise ARTICLE III, s. 4, Fla. Const.; providing members of the Legislature with immunity with respect to any speech or debate in either house of the Legislature.

—was referred to the Legislative Committee.

By Commissioner Hawkes-

**Proposal 91**—A proposal to revise ARTICLE VII, s. 4, Fla. Const.; providing for certain pollution control devices to be classified by general law and assessed solely on the basis of character or use.

-was referred to the Finance and Taxation Committee.

By Commissioner Nabors-

**Proposal 92**—A proposal to revise ARTICLE VIII, s. 1, Fla. Const.; providing that noncharter counties have such power of self-government as is not inconsistent with general law or any special law approved by the electors.

—was referred to the Local Government Committee.

By Commissioner Henderson—

**Proposal 93**—A proposal to revise ARTICLE X, s. 4, Fla. Const.; eliminating the prohibition against devising a homestead if the owner is survived by a spouse or minor child.

—was referred to the General Provisions Committee.

By Commissioner Evans-

**Proposal 94**—A proposal to revise ARTICLE V, s. 10, Fla. Const.; providing that candidates for judicial office may not be precluded from taking a public position on issues.

—was referred to the Judicial Committee.

By Commissioner Evans-

**Proposal 95**—A proposal to revise ARTICLE I, s. 16, Fla. Const.; requiring that the state reimburse a person charged with a crime for the costs of a successful defense whenever the charges are dismissed or the person is acquitted.

-was referred to the Judicial Committee.

By Commissioner Nabors-

**Proposal 96**—A proposal to revise ARTICLE I, s. 5, Fla. Const.; prescribing types of communication that are within the purview of the people's right to instruct their representatives.

—was referred to the Local Government Committee.

By Commissioner Evans-

**Proposal 97**—A proposal to revise ARTICLE I, s. 23, Fla. Const.; prohibiting the performance of a partial-birth abortion, as defined, except in specified circumstances; providing that a woman upon whom

such an abortion is performed is not subject to prosecution under this section.

—was referred to the Declaration of Rights Committee.

By Commissioner Planas-

**Proposal 98**—A proposal to revise ARTICLE III, s. 15, Fla. Const.; requiring additional qualifications of candidates for, and members of, the state legislature.

—was referred to the Legislative Committee.

By Commissioner Langley-

**Proposal 99**—A proposal to revise ARTICLE VII, s. 18, Fla. Const.; providing that a county or municipality is not bound by any agency action or administrative rule that requires the expenditure of funds, reduces revenue raising authority, or reduces the percentage of shared state taxes.

—was referred to the Finance and Taxation Committee.

By Commissioner Anthony—

**Proposal 100**—A proposal to revise ARTICLE VIII, s. 2, Fla. Const.; providing methods for the creation, abolition, and merger of municipalities.

-was referred to the Local Government Committee.

By Commissioner Evans-Jones-

**Proposal 101**—A proposal to revise ARTICLE IV, s. 5, Fla. Const.; providing for election of public service commissioners.

-was referred to the Executive Committee.

#### **SPECIAL ORDER**

Committee Substitute for Proposals 31 and 55—A proposal to revise ARTICLE V, s. 14, Fla. Const., and create ARTICLE V, s. 21, Fla. Const.; providing for salaries, costs, and expenses of the judiciary, state attorneys, public defenders, and clerks of the circuit court, and their respective staffs, to be funded from state revenues appropriated by general law; providing for counties to fund the cost of construction, maintenance, utilities, and security of facilities for the judiciary, public defenders, state attorneys, and clerks of the circuit court, and their respective staffs; requiring the Legislature to appropriate funds according to a phase-in schedule established by general law; authorizing the Legislature to require that counties remit fines, costs, and forfeitures for the purpose of funding the operation of the judiciary, state attorneys, and public defenders.

Commissioner Sundberg moved the following amendment which was adopted:

**Amendment 1**—On page 2, lines 3 and 9, delete "judiciary" and insert: State court system

**Committee Substitute for Proposal 70**—A proposal to revise AR-TICLE X, s. 4, Fla. Const.; providing a value limitation on the homestead exemption; authorizing the legislature to change the amount of the value limitation; providing that the homestead exemption does not apply to certain property.

(1) a homestead of a person who has been a resident of the state for at least five years, to the extent of five hundred thousand
