My name is Steve Hough, and I'm representing Florida Fair and Open Primaries.

I would like to thank each commissioner for their service on the CRC, and because I have reviewed tapes of the previous hearings, I know what an arduous task you have undertaken. Thank you!

Florida Fair and Open Primaries is an all-volunteer, non-funded, grassroots organization of independents and NPAs seeking electoral reform of the primary process. We simply want to be allowed to vote in the primaries without being forced to "join" a political party.

What is joining a party anyway? For most, it is nothing more than checking a box at their local Supervisor of Elections office. There's no application to be approved. No membership dues. No loyalty oaths. So I'm just wondering why we are required to check a box in the first place.

According to the Division of Elections' website, there are over 3.1 million Florida voters registered without a party affiliation. That represents over a quarter of the electorate, and the numbers continue to grow. You ALL should be well aware that a majority of Florida voters support open primaries.

Former State Senator, Dave Aronnberg spoke eloquently in Boca Raton, about language adopted by the last CRC twenty years ago, which essentially created a semi-open primary, and voters approved it. However, unlike Mr. Aronberg, our organization wants you to do more than merely close the write-in loophole which clearly circumvents the intent of our present law. We ask that you forward an initiative for a Top Two Open Primary to the 2018 ballot.

A poll, funded by OpenPrimaries.org

(https://d3n8a8pro7vhmx.cloudfront.net/openprimaries/pages/1635/attachments/original/1490631147/FloridaFinalPol I.pdf?1490631147), was conducted in mid-March, and statistically speaking, it reveals that a full 73% of Florida voters support THIS commission putting an initiative for a top two open primary on the 2018 ballot. By the way, that support includes majorities across party lines. As the majority of races are, in fact, decided in the primaries, it is imperative that the rules be changed.

If one of your responsibilities is to carefully consider the public's desires, I believe you will receive ample evidence in support of a top two open primary system over the course of these hearings.

Memorandum

Revision Process

Here are recommendations addressing the Commission's processes in discharging its tasks:

- This Commission is extremely important in that it can place revisions directly on the ballot. It is crucial that this be done in clear view of the public.
- The Commission should schedule additional public hearings around the state so citizens can comment after the commission has decided what proposals are under serious consideration.
- The Commission should establish by rule that no proposal can be adopted without a public comment period.
- The Commission should define the process for proposals for revisions to be submitted by the public. When will the Commission publish information about how the public can submit proposals?
- The Commission's rules should require that records be 'open' as defined and required by Florida open records law.
- The Commission should require that all meetings involving two or more members be noticed as public meetings, to discourage the conduct of serial private meetings and facilitate commission business in view of the public in compliance with the spirit of Florida's government in the sunshine laws.
- The Commission should change its ethical rules so that legislators or other elected officials cannot take campaign contributions from any person or organization lobbying an issue before the CRC.

Constitutional Issues

Here are constitutional recommendations supported by the ACLU of Florida:

- *Preserve the right to privacy in Florida:* Article 1, Section 23 of the Florida Constitution provides for a specific right of privacy and should be preserved without change:
 - o "Every natural person has the right to be let alone and free from governmental intrusion into the person's private life except as otherwise provided herein. This

section shall not be construed to limit the public's right of access to public records and meetings as provided by law."

- Restore voting rights for certain (or all) former inmates who have satisfied the conditions of their sentences.
 - O It is now widely understood that state laws prohibiting felons the vote played an ignoble part in the history of Jim Crow. It is a truism that people convicted of crime pay for it in their loss of liberty for longer or shorter periods of time. There is no good reason, having paid for their crime, that they should suffer also a loss, potentially permanent, of a basic right of citizenship.
- Maintain fair voting districts for Floridians.
- Protect the independence of Florida's judiciary and maintain the system of checks and balances that protects Florida's citizens and ensures a strong democracy. It is a core function of state courts to determine what law is at issue in a given matter. Our constitutional republic rests on fundamental principles of judicial independence and separation of powers guaranteed to the judiciary in Article 2, Section 3 of the Florida Constitution. Both the federal and the Florida constitutions contain separation of powers clauses to emphasize the importance of judicial independence. The commission should deny efforts to impose judicial term limits, split the jurisdiction of the Florida Supreme Court, provide a legislative override of judicial decisions, limit the jurisdiction of appellate courts, or otherwise weaken the independence of the Florida judiciary. Florida is made stronger by equal and independent branches of government.
- Preserve the requirement that the State not fund churches or religious sects ('no aid' provision). Article 1, Section 3, commonly referred to as the "no aid" provision should be preserved without change. ("No revenue of the state or any political subdivision or agency thereof shall ever be taken from the public treasury directly or indirectly in aid of any church, sect, or religious denomination or in aid of any sectarian institution.")
- Preserve a strong public school system for all Florida students. Art. IX, Section 1(a) of the Constitution should be preserved without change (requiring the state to both provide for "the education of all children residing within its borders" and provide "by law for a uniform, efficient, safe, secure, and high quality system of free public schools that allows students to obtain a high quality education.")

And here are recommendations suggested by members of the Florida criminal defense bar:

- Provide for parity of funding between state attorneys and public defenders.
 - o I will address this point in my remarks to the Commission.
- Revise Article X, Sec. 9, sometimes called "the Savings Clause."
 - o This is the proposal of Greg Newburn, PUB 700003:
 - SECTION 9. Repeal of criminal statutes.

- Repeal or amendment of a criminal statute shall not prohibit affect prosecution or punishment for any crime previously committed before such repeal. See http://flcrc.gov/Proposals/Public/700003.
- Absent the proposed change, Florida would be unable to apply salutary changes in our law to persons already serving sentences. (E.g., if the Legislature passed a law making possession of cocaine a misdemeanor, the Savings Clause would prevent the reduction of sentences currently being served). Florida is apparently the only state with such a clause.
- Restore Florida's right to exercise a robust federalism by repealing the last two sentences of Art. I, Sec. 12.
 - o SECTION 12. Searches and seizures.—The right of the people to be secure in their persons, houses, papers and effects against unreasonable searches and seizures, and against the unreasonable interception of private communications by any means, shall not be violated. No warrant shall be issued except upon probable cause, supported by affidavit, particularly describing the place or places to be searched, the person or persons, thing or things to be seized, the communication to be intercepted, and the nature of evidence to be obtained. This right shall be construed in conformity with the 4th Amendment to the United States

 Constitution, as interpreted by the United States Supreme Court. Articles or information obtained in violation of this right shall not be admissible in evidence if such articles or information would be inadmissible under decisions of the United States Supreme Court construing the 4th Amendment to the United States Constitution.

History.—Am. H.J.R. 31-H, 1982; adopted 1982.

- These two sentences extinguished federalism by mandating that Florida courts interpret the Florida Constitution's prohibition against unreasonable search and seizure in conformance with the decisions of the United States Supreme Court interpreting the Fourth Amendment to the United States Constitution. Thus, as a result of this 1982 amendment, Florida can no longer uphold the fundamental tenet of federalism that the states, under their state constitutions, can guarantee more constitutional protection to its citizens than does the federal government through the federal courts. Constitutional conservatives should be receptive to this proposal.
- The 1982 amendment that added these two sentences was a knee-jerk reaction to the crime wave of the late 1970's and early 1980's caused by a big increase in cocaine trafficking. However, the effect of the 1982 amendment was not explained to the voters, because the ballot summary failed to state that the addition of these two sentences to Article I, Section 12 would actually limit the constitutional rights of the state's citizens, not expand those rights. *See Grose v. Firestone*, 422 So. 2d 303 (Fla. 1982). And compare it with the later case of

Armstrong v. Harris, 773 So.2d 7 (Fla. 2000), where the Court held that the effect of the amendment must be explained in the ballot summary. In Armstrong, the Court vacated a constitutional amendment after the voters passed it, because the ballot summary failed to explain that the amendment extinguished an important principal of federalism, namely, that the states can, if they wish, provide more constitutional protection under the state constitution than is provided under the federal constitution. Our Court said:

"...[O]ur system of constitutional government is grounded on the principle of 'robust individualism' and that our state constitutional rights thus provide greater freedom from government intrusion into the lives of citizens than do their federal counterparts:"

And the Court concluded: "In short: The federal Constitution . . . represents the floor for basic freedoms; the state constitution, the ceiling."
