ten mills; for all school purposes, ten mills; for water 30 management purposes for the northwest portion of the state lying 31 32 west of the line between ranges two and three east, 0.05 mill; for water management purposes for the remaining portions of the 33 state, 1.0 mill; and for all other special districts a millage 34 35 authorized by law approved by vote of the electors who are 36 owners of freeholds therein not wholly exempt from taxation. A 37 county furnishing municipal services may, to the extent authorized by law, levy additional taxes within the limits fixed 38 39 for municipal purposes.

40 (c) Counties served by an open-access public institution 41 whose primary mission and responsibility includes providing 42 lower level undergraduate instruction and awarding associate 43 degrees shall be authorized by law to levy a local option sales tax to supplement the funding of the institution. The tax may 44 45 not be levied unless approved by the electors of each county served by the institution. The local option tax shall sunset 46 47 after five years and may be reauthorized by the electors as 48 provided by law.
