24 28 Resolution of the Taxation and Budget Reform Commission A resolution proposing an amendment to Section 25 of Article I and the creation of a new section in Article XII of the State Constitution to provide for a taxpayer's full and fair opportunity to challenge the assessment of property for ad valorem taxation.

Be It Resolved by the Taxation and Budget Reform Commission:

That the following amendment to Section 25 of Article I and the creation of a new section in Article XII of the State Constitution is agreed to and shall be submitted to the electors of this state for approval or rejection at the next general election or at an earlier special election specifically authorized by law for that purpose:

## ARTICLE I

## DECLARATION OF RIGHTS

SECTION 25. Taxpayers' Bill of Rights.--

- By general law the legislature shall prescribe and adopt a Taxpayers' Bill of Rights that, in clear and concise language, sets forth taxpayers' rights and responsibilities and government's responsibilities to deal fairly with taxpayers under the laws of this state. This section shall be effective July 1, 1993.
- (b) Every taxpayer has a right to a full and fair opportunity to challenge the government's assessment of the value of the taxpayer's property for purposes of ad valorem taxation. The legislature shall provide for such challenges by
