RESPONSE TO PETITION FOR LEAVE
TO RESIGN PERMANENTLY PENDING DISCIPLINARY PROCEEDINGS

THE FLORIDA BAR, through undersigned counsel, files this response to the petition of Frank W. Peterman for leave to resign permanently pending disciplinary proceedings under The Florida Bar Integration Rule, Article XI, Rule 11.08, and states:

1. The Board of Governors of The Florida Bar approved Mr. Peterman's Petition for Resignation at its September 19-22, 1984 meeting.

2. In his Petition for Leave to Resign Permanently, Mr. Peterman has stated the following:

- A. That Mr. Peterman is endeavoring to make restitution to his clients as noted in the petition.
- B. That Mr. Peterman has agreed to cooperate with any client security fund investigation made by The Florida Bar.
- C. That Mr. Peterman has waived confidentiality of all disciplinary matters mentioned in his Petition for Resignation.


