PETITION FOR LEAVE TO RESIGN WITHOUT LEAVE TO REAPPLY

Pursuant to Florida Bar Integration Rule, article XI, Rule 11.08, ROBERT L. WILSON, a member of The Florida Bar, files this Petition for Leave to Resign Without Leave to Reapply, pending disciplinary proceedings and says:

1. Petitioner was admitted to practice law in Florida in 1947. Petitioner is currently residing in Florida and practicing law at 538 First Avenue North, St. Petersburg, Florida.

2. Petitioner has no prior discipline and there are no other pending matters against petitioner.

3. Pending disciplinary action against Petitioner involves the following:

a. Petitioner, under power of attorney from Mrs. Jennie H. Gallon, age 89, did manage her monies consisting of Certificates of Deposit amounting to \$36,000.00 from December 1981 to March 15, 1985, as well as funds in bank savings and checking accounts during the above period of time. Petitioner used various of the above funds totaling approximately \$39,000.00 plus interest for his own personal use, to wit, to help support himself and his family.

b. Petitioner has failed to return the above monies to Mrs. Gallon upon demand and has no funds or property whereby he can do so.

4. Petitioner waives confidentiality of this proceeding, pursuant to Florida Bar Integration rule, article XI, Rule 11.12(1)(a).

5. Petitioner agrees to cooperate fully with any investigation made in connection with the Client Security Fund of The Florida Bar.

6. Petitioner will make all reasonable efforts to reimburse Mrs. Gallon who suffered monetary losses as a result of his actions.


7. Petitioner will also make all reasonable efforts to reimburse the Client Security Fund of The Florida Bar for payments made by the fund as a result of his conduct.

8. Petitioner freely and voluntarily submits this Petition to Resign without Leave to Reapply, and he states there was no intent on his part to injure Mrs. Gallon or to cause her to suffer any loss.

WHEREFORE, Petitioner, ROBERT L. WILSON, respectfully requests this Court to grant his petition striking his name from the roll of attorneys in the State of Florida.
