REFEREE'S REPORT

I. <u>SUMMARY OF PROCEEDINGS</u>: Respondent, Antonio C. Piggee, tendered a conditional guilty plea, in writing, pursuant to Fla. Bar Integr. Rule, article XI, Rule 11.13(6)(a). The undersigned was appointed as referee upon complainant's petition for approval of such guilty plea. The complainant has appeared by David M. Barnovitz, bar counsel and the respondent has appeared, pro se.

II. FINDINGS OF FACT AS TO EACH ITEM OF MISCONDUCT FOR WHICH RESPONDENT IS CHARGED:

A. Attached hereto and incorporated by reference herein is the conditional guilty plea for consent judgment tendered by respondent, as aforesaid.

B. I find as fact each and every allegation recited in such plea in paragraphs numbers 1 through 7, inclusive and paragraph 9.

III. <u>RECOMMENDATIONS AS TO WHETHER OR NOT RESPONDENT SHOULD BE FOUND</u> <u>GUILTY</u>: I recommend that the respondent be found guilty of violating Fla. Bar Integration Rule, article XI, Rule 11.02(3) proscribing commission by a lawyer of any act contrary to good morals and of violating Disciplinary Rule 1-102(A)(3) of the Code of Professional Responsibility which prohibits an attorney from engaging in illegal conduct involving moral turpitude.

IV. RECOMMENDATIONS AS TO DISCIPLINARY MEASURES TO BE APPLIED:

In light of respondent's lack of a prior discipline history, his lack of a prior criminal record and the responsible manner in which he fulfilled his duty in reporting his misconduct to the bar I recommend that respondent be suspended from The Florida Bar for a period of sixty (60) days with automatic reinstatement, such suspension to commence as directed by the Supreme Court of Florida.
