**SUPPLEMENTAL PETITION FOR WRIT OF CERTIORARI;**  
**SUPPLEMENTAL PETITION FOR REVIEW BY THE FLORIDA SUPREME COURT**

The Petitioner, FRED PARKER BINGHAM, II [hereinafter "Bingham"], hereby files this Supplemental Petition to the Florida Supreme Court for an issuance of a Writ of Certiorari to review the recommendation and decision of the Florida Board of Bar Examiners [hereinafter "**Board**"], denying Bingham's application for admission to the Florida Bar. This Supplemental Petition incorporates by reference each and all factual matters and legal argument provided to this court in the original Petition for Writ of Certiorari and Petition for Review filed with this Court, along with Appendix, on November **28, 1989**. In support thereof, Petitioner provides the following:

**I**  
**BASIS FOR JURISDICTION**

This Supplemental Petition for the issuance of a Writ of Certiorari and/or Supplemental Petition for Review is brought pursuant to Article III, Section 4(b), of the Rules of the Supreme Court of Florida Relating to Admissions to the Bar, or alternatively, Article IV, Section 13, of the Rules of the Supreme Court of Florida Relating to Admissions to the Bar, and also pursuant to Rule **9.030**, and Rule **9.100**, Florida Rules of Appellate Procedure. The initial petition in this cause was filed on or about November **28, 1989**; due to Bingham's uncertainty regarding the Board's reconsideration of his application, on or about November **28, 1989** Bingham simultaneously filed a Petition for Reconsideration with the Board under Article III,

Section 4(a), wherein he also petitioned for a waiver of the requirements of Article III, Section 1(c).

By letter dated November 30, 1989, the Board informed this Court that it had no objection to the granting of a stay of Bingham's Petition for Certiorari, pending the Board's decision on the Petition for Reconsideration.

On or about January 19, 1990 [received by Bingham on January 22, 1990], the Board denied Bingham's request for reconsideration and reaffirmed that Bingham:

... has not provided sufficient evidence of his qualifications under Article III, Section 1(c)(2) of the Rules of the Supreme Court of Florida Relating to Admissions to the Bar.

and

... the Board ruled that it will not waive the 10-year requirement under Article III, Section 1(c)(1) to permit the applicant's tenure as a judicial officer to be counted or to permit the applicant's practice before federal courts while he was residing in Florida to be counted.

[January 19, 1990 letter attached hereto and incorporated herein as Exhibit "A"].

Bingham provides no additional factual nor legal argument at this time, but incorporates by reference all factual matters and legal argument previously provided to this Court in his original petition, along with Appendix, filed on or about November 28, 1990. Bingham does, however, request oral argument.


## **II** **THE NATURE OF THE RELIEF SOUGHT**


