The Probate Rules Committee of The Florida Bar, pursuant to the procedure established by Rule of Judicial Administration 2.130(e), submits its report of proposed changes to the Florida Probate Rules. This report comes upon the Court's order of September 29, 1989, requesting this committee to proceed outside its four-year cycle to redraft and rewrite the Florida Probate Rules in compliance with numerous legislative changes to the Florida Guardianship Law.

Each rule change or addition was presented to the full committee and voted upon. This request contains the proposals that were passed out of the committee by at least a majority vote and pursuant to the committee's internal operating procedures.

All of the rule changes were presented to the Florida Bar Board of Governors and the Board voted unanimously (34-0) in favor of these revisions on October 4, 1990.

The attached set of rules includes changes to all three parts of the Florida Probate Rules. In "Part I - General" the committee proposes amending Rule 5.050 governing transfers of proceedings to reflect changes in the guardianship statute governing venue. In "Part II - Probate" the committee proposes amending Rule 5.240 and deleting Rule 5.495 to reflect changes in the statutes governing creditors' claims. In "Part III - Guardianship" the committee proposes numerous amendments to all of the rules in Part III to reflect the major revision of the Florida Guardianship Law passed in 1989 and the further changes made to the Law in 1990. These substantive rules changes are

accompanied by many editorial changes as well as amendments to create a gender neutral document.


The Florida Probate Rules Committee of The Florida Bar hereby presents its completed set of rules incorporated within the attached pages, in three-column format.


REQUEST FOR ORAL ARGUMENT
