PER CURIAM.

We granted review of <u>Gillette v. State</u>, 571 So.2d 600, 600 (Fla. 2d DCA 1990), to answer the following certified question of great public importance:

When a double jeopardy violation is alleged based on the crimes of sale and possession (or possession with intent to sell) of the same quantum of contraband and the crimes occurred after the effective date of section 775.021, Florida Statutes (1988 Supp.), is it improper to convict and sentence for both crimes?

We have jurisdiction pursuant to article V, section 3(b)(4) of the Florida Constitution. We answered this question in the negative in <u>State v. McCloud</u>, no. 75,975 (Fla. Feb. 28, 1991), and <u>State v. V.A.A.</u>, no. 75,902 (Fla. Feb. 28, 1991). Therefore, we quash the opinion under review with instructions to affirm the conviction and sentence for possession of cocaine.

It is so ordered.
