State, 611 So. 2d 58 (Fla. 3d DCA 1992), in support of its opinion in the instant case and Roberts is currently pending before this Honorable Court, Respondent agrees that there is express conflict authorizing jurisdiction in this Honorable Court.

#### ARGUMENT

THE DECISION OF THE THIRD DISTRICT COURT OF APPEAL IS IN CONFLICT WITH A DECISION OF ANOTHER COURT OF APPEAL, ALLOWING THIS COURT TO EXERCISE ITS JURISDICTION.

This Court has discretionary jurisdiction to review decisions of district courts of appeal that expressly and directly conflict with a decision of another district court of appeal on the same question of law. Art. I, sec. 3 (b)(3), Fla. Const.; Fla. R. App. P. 9.030 (a)(s)(A)(iv). A district court's per curiam decision that is pending in this Court constitutes express conflict. State v. Lofton, 534 So. 2d 1148 (Fla. 1988); Jollie v. State, 405 So. 2d 418 (Fla. 1981).

The opinion of the Third District in the instant case cited (Anthony) Roberts v. State, 611 So. 2d 58 (Fla. 3d DCA 1992) in its per curiam decision affirming Petitioner's conviction below. (App).

Roberts certified express and direct conflict with Graham v. State, 559 So. 2d 343 (Fla. 4th DCA 1990), and is presently pending review in this Court as Case No. 81,182 on the same issue of law. This being so, the State concedes that this Court has jurisdiction to review the instant case. Art. I, sec. 3 (b)(3), Fla. Const.; Jollie, 405 So. 2d 418.

### CONCLUSION

WHEREFORE, based upon the foregoing reasons and authorities cited herein, Respondent agrees that conflict jurisdiction is vested in this Honorable Court.
