BRIEF OF PETITIONER ON JURISDICTION

I. PRELIMINARY STATEMENT

Tommy Lee Williams was the "defendant" in the trial court, "appellant" before the District Court of Appeal, First District, and will be referred to in this brief as "petitioner". Filed with this brief is an appendix containing a copy of the district court's decision as well as other matters pertinent to the jurisdiction of the Court. Reference to the appendix will be by use of the symbol "A" followed by the appropriate page number in parentheses.

II. STATEMENT OF THE CASE AND FACTS

By a per curiam opinion dated November 22, 1993, the District Court of Appeal, First District, affirmed petitioner's conviction, citing to its decision in <u>Rock v. State</u>, 622 So.2d 487 (Fla. 1st DCA 1993)(A-1). Notice To Invoke Discretionary Jurisdiction was timely filed December 21, 1993 (A-2-3).

III. SUMMARY OF ARGUMENT

IV. ARGUMENT

THE DECISION RENDERED IN PETITIONER'S CASE BY THE DISTRICT COURT OF APPEAL, FIRST DISTRICT, EXPRESSLY AND DIRECTLY CONFLICTS WITH DECISIONS OF OTHER DISTRICT COURTS OF APPEAL OR OF THE SUPREME COURT OF FLORIDA ON THE SAME QUESTION OF LAW.

Petitioner's conviction was affirmed on authority of <u>Rock</u> <u>v. State</u>, <u>supra</u>. The appellant in <u>Rock</u> timely invoked the jurisdiction of this Court (A-4-5). <u>Rock v. State</u>, Case No. 82,530. <u>Rock</u> is pending jurisdiction in this Court. <u>See</u> <u>Zilliams v. State</u>, 18 FLW D2449 (Fla. 1st DCA Nov. 19, 1993)(on rehearing).

If the Court accepts the <u>Rock</u> case for review on the merits, it must also accept the instant case on authority of <u>Jollie v. State</u>, 405 So.2d 418 (Fla. 1981)(district court opinion which cites as controlling authority a decision that is either pending review in or has been reversed by supreme court constitutes prima facie express conflict and allows supreme court to exercise its jurisdiction).

V. CONCLUSION

Based upon the above, petitioner urges the Court to accept jurisdiction should it accept jurisdiction in <u>Rock v. State</u>, Case No. 82,530.
