We have for review <u>State Department of Revenue v. Port of</u> <u>Palm Beach District</u>, 650 So. 2d 700 (Fla. 4th DCA 1995), which expressly and directly conflicts with the opinion in <u>Sarasota-</u> <u>Manatee Airport Authoritv v. Mikos</u>, 605 So. 2d 132 (Fla. 2d DCA 1992), <u>review denied</u>, 617 So. 2d 320 (Fla. 1993). We have jurisdiction. Art. V, § 3(b) (3), Fla. Const.
