Since the decision of the Fifth District Court of Appeal in the instant case relies on a case currently pending in this court for its precedent, this court has jurisdiction to accept the appeal.

ARGUMENT

THIS COURT HAS THE DISCRETION TO ACCEPT JURISDICTION IN THE INSTANT CASE.

In Jollie v. State, 405 So. 2d 418 (Fla. 1981), this court held that when a district court issues a decision where the controlling precedent is presently pending in this court, there is "prima facie express conflict (which) allows this court to exercise its jurisdiction." Id. at 420. The decision of the Fifth District Court of Appeal in the instant case relied on <u>Armstrong v. State</u>, 640 So. 2d 1250 (Fla. 5th DCA 1994) which is currently pending review before this court. This court therefore has discretion to entertain the review sought by petitioner.

CONCLUSION

Since this court has accepted jurisdiction in <u>Armstrong</u>, respondent respectfully prays this honorable court accept jurisdiction in this case pursuant to the holding in <u>Jollie</u>.
