PER CURIAM.

The State appeals the Second District Court of Appeal's decision in <u>State v. Ayers</u>, 665 So. 2d 296 (Fla. 2d DCA 1995).¹

In <u>Ayers</u>, the Second District relied on our prior decision in <u>State v. Winters</u>, 346 So. 2d 991 (Fla. 1977), to declare section 827.05, Florida Statutes (1993), unconstitutional. We have jurisdiction. Art. V, § 3(b)(1), Fla. Const.

Consistent with the Second District's decision, this Court recently concluded that section 827.05, as amended in 1977, remains unconstitutionally vague under our prior decision in Winters. State v. Mincey, 21 Fla. L. Weekly S169 (Fla. April 18, 1996). Accordingly, we affirm.

It is so ordered.
