WELLS, J.

We have for review <u>Coyne v. State</u>, 732 So. 2d 455 (Fla. 4th DCA 1999), in which the Fourth District Court of Appeal affirmed the trial court in a per curiam decision without a written opinion, citing <u>Harbaugh v. State</u>, 711 So. 2d 77, 83 (Fla. 4th DCA 1998). We accepted jurisdiction because <u>Harbaugh</u> was pending in this Court upon a certified question of great public importance as to whether, when a defendant requests that the jury determine the existence of prior DUI convictions in a felony DUI trial, the bifurcated procedure of <u>State v. Rodriguez</u>, 575 So. 2d 1262 (Fla. 1991), should be amended in light of <u>United States v.</u>

Gaudin, 515 U.S. 506 (1995). See Jollie v. State, 405 So. 2d 418 (Fla. 1981). We have jurisdiction pursuant to article V, section 3(b)(3), Florida Constitution.

In <u>Harbaugh</u>, we answered the certified question in the affirmative and remanded to the district court for further proceedings in accord with our opinion. <u>State v. Harbaugh</u>, SC93037 (Fla. March 9, 2000). Accordingly, we quash the decision of the Fourth District in <u>Coyne</u> to the extent that it is inconsistent with our opinion in <u>Harbaugh</u>, and we remand for further proceedings in accord with <u>Harbaugh</u>.

It is so ordered.
