PER CURIAM.

We have for review the decision in <u>State v. Johnson</u>, 743 So. 2d 45 (Fla. 2d DCA 1999), in which the district court affirmed the lower court's sentencing decision based upon <u>State v. Cotton</u>, 728 So. 2d 251 (Fla. 2d DCA 1998)(holding that the trial court has discretion to determine whether a defendant should be sentenced as a prison releasee reoffender pursuant to section 775.082(8), Florida Statutes (1997)). In so doing, the Second District certified conflict with <u>Woods v. State</u>, 740 So. 2d 20 (Fla. 1st DCA 1999), and <u>McKnight v. State</u>, 727 So. 2d 314 (Fla. 3d DCA 1999). We

have jurisdiction. See V, § 3(b)(4), Fla. Const.

We recently quashed the Second District's decision in <u>Cotton</u>, and approved the First District's decision in <u>Woods v. State</u>, 740 So. 2d 20 (Fla. 1st DCA 1999), holding that the Act, as properly interpreted by the First District, does not violate separation of powers, and rejecting other constitutional challenges to the Act. <u>See State v. Cotton</u>, Nos. SC94996 & SC95281 (Fla. June 15, 2000). Accordingly, for the reasons expressed in <u>Cotton</u>, we quash the Second District's decision in this case with directions to remand the case to the trial court for proceedings consistent with our opinion in <u>Cotton</u>.

It is so ordered.
