**MOTION FOR RECONSIDERATION OF RESPONDENT'S
OBJECTIONS TO EXHIBITS 7 & 8 OF
JQC'S PREHEARING STATEMENT**

COMES NOW the Respondent, by and through her undersigned attorney, and moves the hearing chair in this matter to reconsider her ruling as to items 7 & 8 in JQC's Prehearing Statement, and in support thereof would show:

1. That in Respondent's objections to the Exhibits listed in JQC's Prehearing Statement, Respondent wrongly referred to a draft of said Statement, and omitted an objection to item 7 (Respondent's response to her attorney's withdrawal Motion) and listed her objection to item number 8 as if it referred to item number 7. 3. As stated above, Respondent's objection to item number 8 (a flyer) is the same as written for item number seven in the original Objection to Exhibits. Please accept the original objection to item seven as the objection to item number 8.
