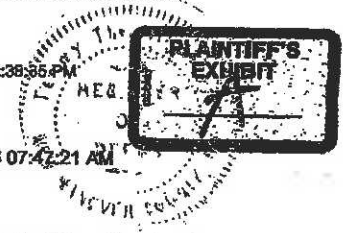
Accordingly, it is ORDERED and ADJUDGED:

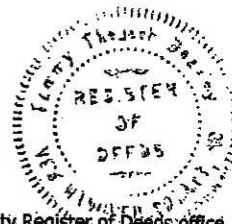

An order that exceeds the jurisdiction of the court is void, and can be attacked in any proceeding in any court where the validity of the judgment comes into issue. (See *Rose v. Himely* (1808) 4 Cranch 241, 2 L ed 608; *Pennoyer v. Neff* (1877) 95 US 714, 24 L ed 685; *Thompson v. Whitman* (1873) 18 Wall 457, 21 L ED 897; *Windsor v. A void judgment does not create any binding obligation. Federal decisions addressing void state court judgments include *Kalb v. Feuerstein* (1940) 308 US 433, 60 S Ct 343, 84 L ed 370. Federal judges issued orders permanently barring Stich from filing any papers in federal courts. After Judges Robert Jones and Edward Jellen corruptly seized and started to liquidate Stich's assets, Judge Jones issued an unconstitutional order barring Stich from filing any objection to the seizure and liquidation.

To Whom It May Concern ,

We write to request that Larry Wetzel, an American Citizen who has been unjustly detained in Santa Rosa County Jail of Florida, be granted a 'habeas corpus' and immediately released/ returned to either Georgia/ Arizona the places of his latest residencies or the Texas airport where he was arrested on a Fraud warrant without being indicted for a crime in Florida.

Larry Wetzel has worked peacefully in Georgia/Arizona since 2014. There appears to be no evidence to substantiate the allegation of Fraud other than an unsubstantiated allegation in the Civil Court of Santa Rosa County Florida by a supposedly Plaintiff, Christopher Duffy, in Illinois without an affidavit of said allegation. Moreover, the same authorities have repeatedly denied regular and appropriate 'access to the courts' by 'Pro Se' litigants in the Santa Rosa County jail.

Larry Wetzel's unlawful imprisonment has been raised repeatedly by his family and with affidavits presenting evidence he is being detained against his Consent and without Lawful Authority by the authorities in Santa Rosa County Florida and the Florida Supreme Court. Unfortunately, efforts to secure Larry Wetzel's release have been unsuccessful. We are deeply disappointed in the officials disallowing a citizen's right to file a 'Habeas Corpus' in violation of 'due process', with and by the County Courts publishing undocumented rulings of the Florida Supreme Court and those orders being used in violation of the Florida Constitution provision, 'Access to the Courts' by the County Officials including the Sheriffs in Santa Rosa County Florida denying 'Pro Se' litigants filings / Habeas Corpus.

We hope that the Santa Rosa Sheriff will reevaluate the situation in the light of now knowing Larry Wetzel was not a fugitive from justice in that he had not been indicted by a Grand Jury, nor convicted of a Felony in Florida and therefore he was kidnapped in Texas at the airport and brought to Florida on a bogus warrant.

In the spirit of 'due process', we respectfully ask you to consider Larry Wetzel's case and respond to how the recent treatment of him, by hand cuffing and putting him in a dog pen to transport from Texas to Florida jail, places significant strain not only on him and his family, but also on the bilateral relationship between the United States and

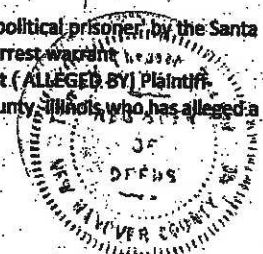

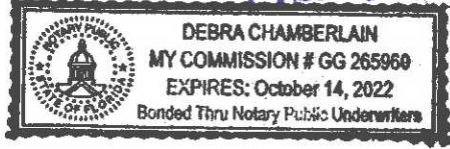

- The Court of Santa Rosa County Florida doesn't have jurisdiction in civil court to Order Larry Wetzel to be extradited from Houston Texas with a criminal warrant (14001456 CFMXAX) Fraud-False Statement and Order him to turn over private documents to the Plaintiff's attorneys and pay \$57,947.41 in attorneys fees in violation of 'due process' and Amendment IV AND V of the Bill of Rights of the U.S. Constitution. (See Exhibit D).
- 'Subsequently, a Final Judgment Awarding Attorney's fees and costs was executed by the Honorable John L. Miller on June 27, 2016.' This Order isn't in the Santa Rosa County Court but instead in the Escambia County Court's record; yet it is being used to arrest Larry Wetzel in Santa Rosa County for 'Contempt of Court' for refusing to surrender his private papers and pay \$57,947.41 without a jury award and in violation of the 'due process' clause of the U.S. Constitution.

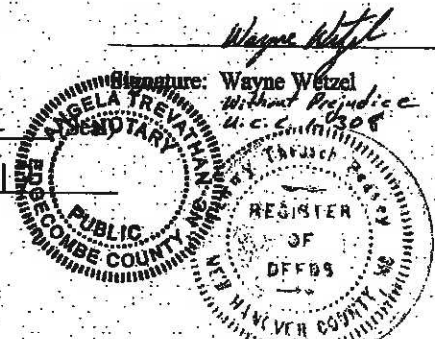
WHEREFORE: Larry Wetzel had a Georgia Drivers License issued 11/12/2014 (witness affidavit) AND has exhibited evidence of probable cause to believe that he is detained without LAWFUL AUTHORITY. "An Order that exceeds the jurisdiction of the court is void," If the court didn't have jurisdiction on 12/15/14, it cannot retain jurisdiction for a later ruling 'Contempt of Civil Court' for refusing to turn over private papers on (June 28, 2016) and refusal to pay Plaintiff's Attorney Fees.

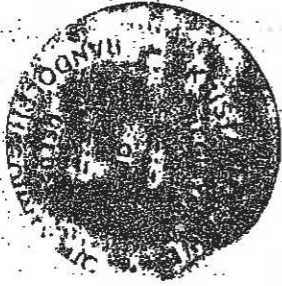
