PER CURIAM.

We have for review <u>Bennett v. State</u>, 904 So. 2d 447 (Fla. 4th DCA 2005), in which the Fourth District Court of Appeal cited its decision in <u>Richardson v. State</u>, 884 So. 2d 950 (Fla. 4th DCA 2003), <u>reh'g granted in part</u>, 884 So. 2d 950, 952 (Fla. 4th DCA 2004), <u>quashed</u>, 915 So. 2d 86, 89 (Fla. 2005). At the time that the Fourth District Court of Appeal issued its decision in <u>Bennett</u>, <u>Richardson</u> was pending review in this Court. We have jurisdiction. <u>See</u> art. V, § 3(b)(3), Fla. Const.; Jollie v. State, 405 So. 2d 418 (Fla. 1981).

The petition for review is granted. On the authority of our decision in <u>State</u> v. <u>Richardson</u>, 915 So. 2d 86 (Fla. 2005), the decision under review is quashed,

and this matter is remanded to the Fourth District Court of Appeal for reconsideration upon application of this Court's decision in <u>Richardson</u>.

Any and all pending motions and requests are hereby denied as moot.
