COMMENTS OF THE FLORIDA ASSOCIATION OF CRIMINAL DEFENSE LAWYERS

The Florida Association of Criminal Defense Lawyers ("FACDL") submits the following comments in support of the proposed standard jury instructions in criminal cases directing jurors to refrain from using electronic technologies to research or communicate with others about cases on which they serve. FACDL believes that the proposed instructions will further help to ensure that criminal defendants in this state receive fair trials, free of any improper outside influence on jurors. FACDL is also in favor of the Committee on Standard Jury Instructions in Criminal Cases continuing to study whether trial judges should collect cell phones and electronic devices from jurors prior to service (or at least prior to jury deliberations). FACDL is in favor of a rule/instruction that would require trial judges to collect jurors' cell phones and electronic devices.

Finally, FACDL notes that the federal court Judicial Conference Committee on Court Administration and Case Management ("CACM") recently endorsed a set of suggested jury instructions for use by federal district court judges to help deter jurors from engaging in the inappropriate use of electronic technologies. Copies of the proposed instructions and a letter from the Honorable Julie A. Robinson, Chair of the CACM, are attached to these comments.
